Female Sale April 28, 2018 Requirements

Registered Angus Females

* Age Limit -10 Years * **DDP Females** must be tested and designated DDF or DDC. Designations other than DDP and DDA are eligible to be sold. No designation means that animal is not a potential carrier. *Must be tested free for AM, NH and CA or have no carrier ancestor. *Any female 24 months or older must be safe in calf except a cow with a calf less than eight months old. *All Cattle must be clipped. *All EPDs available, including sire and dam will be used. *There will be a \$200 consignment fee per lot. Consignment fees will be refunded unless the female is removed from the sale after it appears in the catalog. Exceptions to this are injury and bred females coming up open. Veterinarian certification is required for both reasons. No other fee will be charged for a female removed from the sale. *In an effort to increase quality consignments of females, total selling expense will be a flat 10%.

Commercial Angus Influenced Females

*Maximum of 30 commercial Angus influenced females *Consignments should be in lots of 3. *Consignments must be either: 1. Open heifers ready to breed 2. Bred Heifers 3. Bred Cows not older than 4 years (no pairs) There will be a \$75 consignment fee per lot of three. Consignors total selling expense will be 6%. Priority for Angus influenced female consignments will be members first. Past bull buyers will be allowed to consign Angus influenced females, and if there are more than 10 lots consigned, the secretary will hold a drawing with two additional board members present.

Registered Angus Yearling Bulls

A limited number of yearling bulls (bulls too young for the bull sale) may be accepted if stall space allows and sold at the conclusion of female sale.

LAA Futurity

1. LAA Membership must be Current. LAA Members may nominate heifers in the following way:
2. Consign Heifers in the Louisiana Angus Female Sale. Heifers declared for the futurity will pay a \$200 entry fee deducted from sale proceeds. Heifers must be born between September 1, 2016 through December 31, 2017.
3. All Nomination fees are non-refundable and will go towards the purse and will be awarded to the champion and reserve champion Heifers.
4. All Heifers nominated will be noted in the sale catalog.
5. Heifers must be less than 2 years old.
6. Heifers must be broke to tie.
7. The Winning breeder from the previous show will be presented with a plaque prior to the sale.

Futurity Show

1. The show will take place during the LJAA field day.
2. Grand and Reserve Champion will split the jackpot 60%/40%, of 50% Grand/40% Reserve/10% to class winners
3. Heifers must have been in Junior's care by May 15 and is open to any junior regardless of the state they are from.

Goal

The goal of this program is to build a working relationship between breeders and juniors throughout Louisiana while creating a quality outlet to sell your open heifers. I believe this will draw a larger number of juniors and buyers to the Female Sale by this added incentive. I also believe it would encourage breeders to become more involved in the LJAA.
